A tax rate of \$0.122476 per \$100 valuation has been proposed by the governing body of WEATHERFORD COLLEGE.

PROPOSED TAX RATE \$0.122476 per \$100 NO-NEW-REVENUE TAX RATE \$0.116449 per \$100 VOTER-APPROVAL TAX RATE \$0.123196 per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for WEATHERFORD COLLEGE from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that WEATHERFORD COLLEGE may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that WEATHERFORD COLLEGE is proposing to increase property taxes for the 2022 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 22, 2022 AT 12:00 pm AT The Community Room of the Emerging Technologies and WorkForce Building at Weatherford College in Weatherford Texas.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, WEATHERFORD COLLEGE is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Weatherford College Board of WEATHERFORD COLLEGE at their offices or by attending the public hearing mentioned above.
