

Weatherford College, in partnership with Condensed Curriculum International (CCI):

Program Summary: This program will prepare students to work as pharmacy technicians in retail or other pharmacy settings and take the Pharmacy Technician Certification Board's PTCB exam. **Course content** includes pharmacy medical terminology, the history of pharmacy, the pharmacy practice in multiple environments, pharmacy calculations and measurements, reading/interpreting prescriptions, and defining drugs by generic and brand names. Through classroom lectures and hands-on labs, students will review dosage calculations, drug classifications, the "top 200 drugs", I.V. flow rates, sterile compounding, dose conversions, aseptic technique, the handling of sterile products, total parental nutrition (TPN), dispensing of prescriptions, inventory control and billing and reimbursement. This program combines **classroom/ lab instruction of 84 hours and the off-site externship of 80 hours** to provide students with a comprehensive learning experience.

Starting Pay: U.S. Dept of Labor national average: \$13 – 18 per hour. 16 students per class

Tuition: \$1700.00 - Without the Externship: \$1,600

Certification: Weatherford College Certificate of Completion will be awarded after completing the course and externship successfully. Graduates will have the option to sit for the Pharmacy Technician Certification Board (PTCB) national exam. **Exam fees are the responsibility of the student.**

Pharmacy Technician Registration Packet Checklist

REQUIREMENTS PRIOR TO REGISTRATION:

ITEMS MUST BE UPLOADED ONLINE AT WC.EDU/WF

- Valid Driver's License or Photo ID
- Signed Social Security Card
- H.S. Diploma, HSE/ GED
- Hepatitis B (series of 3 shots)- Submit a reactive Hep B titer. If non-reactive, student will need to complete a three-dose series or two-dose (Heplisav) series prior to class
- Measles, Mumps, Rubella (MMR)*-born before 1957-one dose or positive titer is required, born in or after 1957-two doses one month apart or positive titer
- Tetanus/Diphtheria/Pertussis (Tdap)*-one dose within the past 10 years
- Tuberculin Skin Test* (TB) - Negative reading
- Varicella (chicken pox) *-two doses unless first dose is prior to age 13 or report of a positive titer
- Satisfactory Criminal Background Check- (WC will process) For students in this course who may have a criminal background, please be advised that the background could keep you from being licensed by the State of Texas. If you have a question about your background and licensure, please check with the Pharmacy Technician Certification Board by calling 1-800-363-8012 or visiting their website at www.ptcb.org. You also have the right to request a criminal history evaluation letter from the applicable licensing agency.

REQUIREMENTS PRIOR TO EXTERNSHIP (COORDINATED THROUGH CCI):

- Updated Resume
- Pharmacy Technician Trainee Registration Application with PTCB* -Should be completed AT LEAST 30 DAYS PRIOR to externship.
- Student Waiver
- Urine Drug Screen* - Coordinated and scheduled by CCI
- Letter from Healthcare provider* stating that you are free from all communicable diseases and cleared to participate in an externship.
- Based on externship site, you may be required to complete additional health exams, tests and/ or provide additional documents."

Students will not be allowed to begin the externship if all requirements are not met prior to first day of externship - No refunds will be given.
